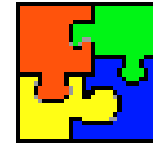

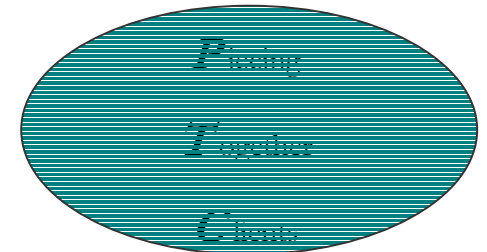

## PROVIDENCE TREATMENT CENTER

Providence was established in 1997 as a stepping-stone between the least restrictive environment (public school) and the most restrictive environment, i.e. residential treatment. PTC was designed to facilitate the return to the community environment.

Providence is a day school and treatment center for children, youth and adults. PTC operates a flexible schedule to meet the needs of its clients and their families. Many parents have been able to return to work due to our schedule and our level of success with their child. Providence's hallmark is an individually tailored school with a low staff to student ratio, highly structured environment with intense behavior treatment and an integrated educational, sociological and medical model. Objectives and goals vary by student but students receive both academic and life skills training with emphasis on their return to a community based program, i.e. school or work. Thus far, PTC has had a great deal of success with reintegration back into the community.

## EDUCATIONAL SERVICES

Certified and highly trained and qualified staff provide small group and one on one instruction to a wide variety of instructional levels and needs. Experience ranges from 3 to 30 years in the field. All staff are trained in PMAB and TBSI.

## MEDICAL SERVICES

Dr. Rafael Guerrero has joined our team as of 2002 as our consulting psychiatrist. Staffings are scheduled on an as needed basis and at the request of other individuals on the treatment team (IEP/ARD Committee). Everyone is welcome to attend, if approved by the legal guardian of the client. There is no obligation to consent to treatment and the appointment is voluntary. This service is *FREE* of charge to families and the child placing agency.\*

\* Dr. Guerrero reserves the right to charge a small fee to the Medicaid or insurance carrier.

## WHO DOES PTC SERVE?

PTC specializes in providing treatment services to children, youth and young adults with learning problems related to behavioral and emotional difficulties. These individuals are very often labeled as difficult to handle. These individuals also have demonstrated that at the time of placement they cannot be managed in a community-based program such as the public school.

PTC specializes in working with individuals that have severe behavior problems related to the following diagnosis:

*Autism Bipolar Disorder ADHD*

*PDD ODD Major Depression*

*Schizophrenia Mental Retardation*

*Developmental Disabilities*

*Multiply Impaired\*\**
